

DISCLAIMER

I understand that the 2010 Battle Against Hunger Bike Tour (the "Tour") will be ridden on public roads and private property without specific oversight by any public safety authorities, and that biking in this manner is an inherently dangerous activity. I acknowledge that participating in the Tour could result in severe injury, disablement, or death. Throughout my participation in the Tour, I voluntarily, explicitly and fully assume all the risks of damage to my property, direct or indirect injury of any kind to my person, no matter how severe, disablement, or death (a "casualty") that impacts me due to my actions or the actions of the Sponsors, Promoters and Managers of the Tour, their Employees or Agents, or any other Participant in the Tour, ("SPMEAP") whether or not the action by any SPMEAP could be considered negligent.

I indemnify and hold all SPMEAP harmless against loss, cost or damage to me arising from a casualty during my participation in the Tour, whether from collision with any fixed object or structure, pedestrian, vehicle, other participant, or due to equipment failure, inadequate safety warnings or precautions, weather conditions, or otherwise, and I shall have no cause of action in tort or claim against any SPMEAP arising out of my participation in the Tour. This indemnification shall bind my personal representative and my heirs and no successor to me shall have any claim, nor be able to maintain any cause of action in tort against any SPMEAP individually or collectively arising out of my participation in the Tour.

I attest that I have the requisite level of physical fitness to safely participate in the Tour. To my knowledge, I have no medical condition that would result in a casualty from my participation in the Tour. I will provide a copy of my health insurance coverage to the Manager. If I am injured and unable to seek emergency medical care I authorize the Manager to obtain such care at my expense. I agree to wear approved head protection gear and will use no type of head phone at any time while bike mounted. I am responsible for providing a satisfactory bicycle and all repair tools and spare parts necessary to keep it in operating condition. To avoid removal from the Tour, I will abide by the general rules of the Tour and any specific instructions given to me by the Manager that he deems necessary for its safe conduct.

I cannot unilaterally modify this indemnification or my obligations hereunder in any manner, and they shall succeed my participation in the Tour.
